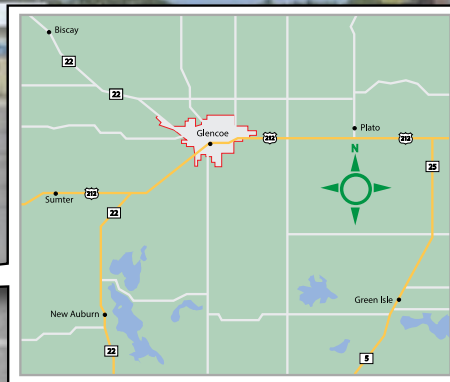
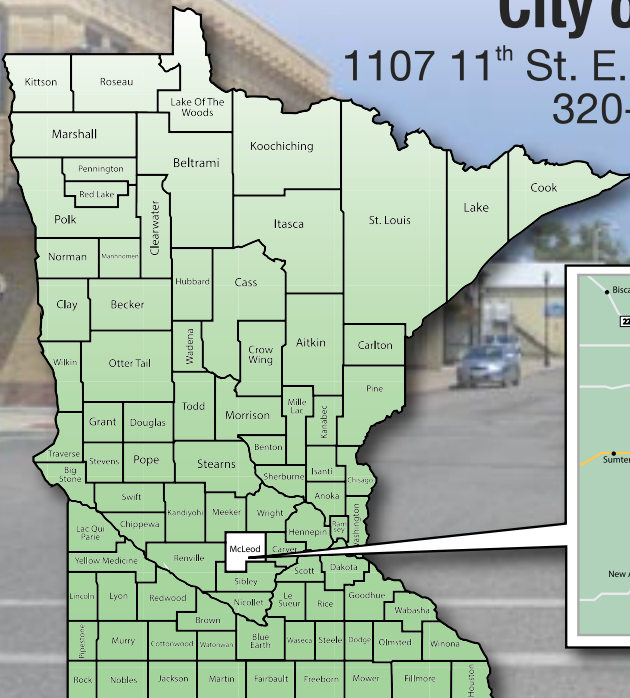

Some city ordinances to be aware of ...

The following are some of the more applicable city ordinances that people need to be aware of in Glencoe:

- Snowbird Ordinance- 421.01 Winter Parking. No person shall park or leave standing any vehicle whether attended or unattended upon any avenue, street or highway within the City of Glencoe between the hours of 1:00 AM to 6:00 AM or until the street has been plowed curb to curb, whichever is later. Winter parking shall last from November 1st through April 1st each winter season.
- The animal control ordinances state that all dogs and cats shall wear a collar and have an identification tag firmly affixed thereto indicating the dog's owner by name, address and phone number. No person shall keep in any one household more than two dogs and/or two cats over the age of six months not to exceed a total of four, without a valid kennel license issued by the city.

GSL: Continue to Grow for the future

The Glencoe-Silver Lake Public School District (GSL) proudly serves the communities of Biscay, Brownton, Glencoe, New Auburn, Plato, and Silver Lake.

Consolidated in 1996 from the former Silver Lake and Glencoe School Districts, and then again with the McLeod West School District in 2009, Glencoe-Silver Lake School District #2859 provides a quality array of academic, co-curricular, extracurricular, social, recreational, and community education programs and services to 1,575 students in grades P-K-12.

The district's grade levels are located in three teaching/learning facilities. Lincoln Elementary School (Glencoe) houses the district's K-2 programs/grades, while Lakeside Elementary School (Silver Lake) will con-

tinue to serve all district students in grades 3-6. Glencoe-Silver Lake Junior-Senior High School (Glencoe), home to students in grades 7-12, is connected to the K-2 elementary and the multi-purpose Panther Field House. The Early Childhood Learning Center, which opened in January of 2014, is also connected, and houses all our Early Childhood Family Education, Early Childhood Special Education, and School Readiness programs and students.

The school district is governed by a six-member School Board which meets monthly (typically on the second Monday of the month) at 1621 E. 16th St., Glencoe. Christopher Sonju is Glencoe-Silver Lake School District's Superintendent of Schools.

Glencoe-Silver Lake School District's teaching, specialist, support, and administrative staffs provide quality programs and services to the com-

munities' pre-school, school-aged, and adult populations. Frequent involvement in staff in-service training and curriculum development ensures the school district's staff employs "best instructional practices" and "current curricular (subject) content." Providing instructional program leadership in the school district are Bill Butler, Elementary School Principal/Child Study Coordinator; Matt Foss, GSL High School/Junior High School Principal; Dan Svoboda, 7-12 Assistant Principal; Joy Freitag, Elementary Assistant Principal; Dean Schwartz, Activities Director; Jeff Jensen, Director of Technology and Information Systems; Matt Muenchow, Director of Community Education/Panther Field House; and Michelle Sander is the School District's Business Manager.

Glencoe-Silver Lake School District #2859 provides an appealing array of program and service features, including the availability of school-aged childcare; learning readiness and early childhood/family education programming; all day/every day kindergarten; striving for lower class sizes, and an excellent number of programs and services at all organizational levels.

Course offerings at GSL High School are found in 12 subject matter disciplines including Agricultural Education, Art, Business, English, Family and Consumer Science, Industrial Technology, Mathematics, Music, Physical Education/Health, Science, Social Studies, and World Languages. Qualifying students at the high school level may participate in the “College in the Classroom” courses, which offer dual (both high school and college/university) credit and/or Advanced Placement Classes (AP Classes). The district also offers students a progressive technology program, which continues its iPad initiative into the elementary curriculum and Chromebooks for our 7-12th graders.

Glencoe-Silver Lake High School has received national recognition for its Project Lead The Way (PLTW) program that gives kids of all ages opportunities in Science, Technology, Engi-

neering and Math. GSL is a fully accredited STEM School through PLTW. PLTW, a nonprofit organization and the nation’s leading provider of STEM education programs, offers a rigorous, world-class curriculum that allows students to apply what they are learning in math and science class to real-life engineering and technology projects.


Specialty programs are offered at Glencoe-Silver Lake to address special circumstances, needs, and interests of students. The district operates a comprehensive, district-wide special education program for students with a range of handicapping conditions, and a migrant summer school program to address the limited English proficiency of select youngsters. Other programs offered are summer school, adult recreation and educational offerings, enrichment, training programs, and much more. Extracurricular and co-curricular programs are an important feature for our students at GSL. Glencoe City Center



It has been thirteen years since the Glencoe City Center began its transformation in 2009 after numerous years of planning to save the historic school building and repurpose it for future generations of operating as a community facility.

The facility's Grand Ballroom is rented throughout the year for various celebrations and performances including weddings, holiday parties, graduation celebrations, concerts and various other social functions. It's rare to have a weekend where the ballroom is not buzzing with activity.

In addition to the ballroom, the facility's meeting rooms host regular gatherings for the local 4-H Club, Girl Scouts, Scouts BSA and a senior citizen group. Its meeting rooms also host reunions, confirmations, anniversaries, bridal and baby showers, birthday parties, business meetings, and other community happenings.

The City Center also is home to the Glencoe Public Library and the Glencoe Woodworking Club. Common Cup Ministry has its offices in the city center, with an entrance on the north side of the building. The or-

ganization distributes diapers, food vouchers, transportation passes, packs meals for students and much more at this location. Here are some of the key features available at the Glencoe City Center.

Grand Ballroom

The Grand Ballroom often holds wedding ceremonies and receptions along with banquets, fundraisers, concerts and other large scale parties. The Grand Ballroom can also be split into two separate spaces, creating the North and South Grand Ballrooms.

South Grand Ballroom

Our small town is stretching into a larger modern area. As a long-time member of Glencoe, the Glencoe Public Library is stretching to match the community support and patron's usage. The Glencoe Library is the hub for research, relaxing reads, and a learning resource.

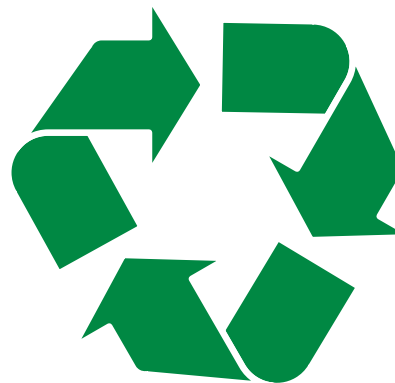

Glencoe's City parks

Glencoe has invested in a collection of neighborhood and pocket parks throughout the community.

The city's public works department maintains the parks. The parks are tobacco-free. Public works park and street superintendent is James Voigt.

The city parks are governed by a parks advisory board consisting of James Eiden, Matt Roberts, Amanda Ortloff, Mike Long, Susan Olson and Jerrod Fisher.

Glencoe has eight parks in the community, covering a total of 60 acres. The parks usually open in late April and close about Oct. 1.

The park shelters open around the middle of May. Rental fees on the shelters are \$75 for Oak Leaf Shelters 4 and 5; \$95 for Oak Leaf Shelter 1; \$85 for Oak Leaf Shelter 3; \$130 for Oak Leaf Shelter 2 and \$100 for Oscar Olson Shelter. Reservations may be made through city offices at 320-864-5586.

The Glencoe Aquatic Center offers fun for all ages. The swimming pool daily fee is \$2 for children ages 0-4 and \$6 per person ages 5 and older. Season passes are \$75 for an individual season pass and \$145 for a family of three members. A family pass is \$175 for five members.



Sunrise Park features a skatepark, playground, pavilions and a soccer field.

The pool may be rented for \$100 an hour for groups up to 30 people and an additional \$15 per hour for increments of 15 people over 30. The pool also can be rented in half-hour increments. Call 864-2959 or 864-5586 for more information.

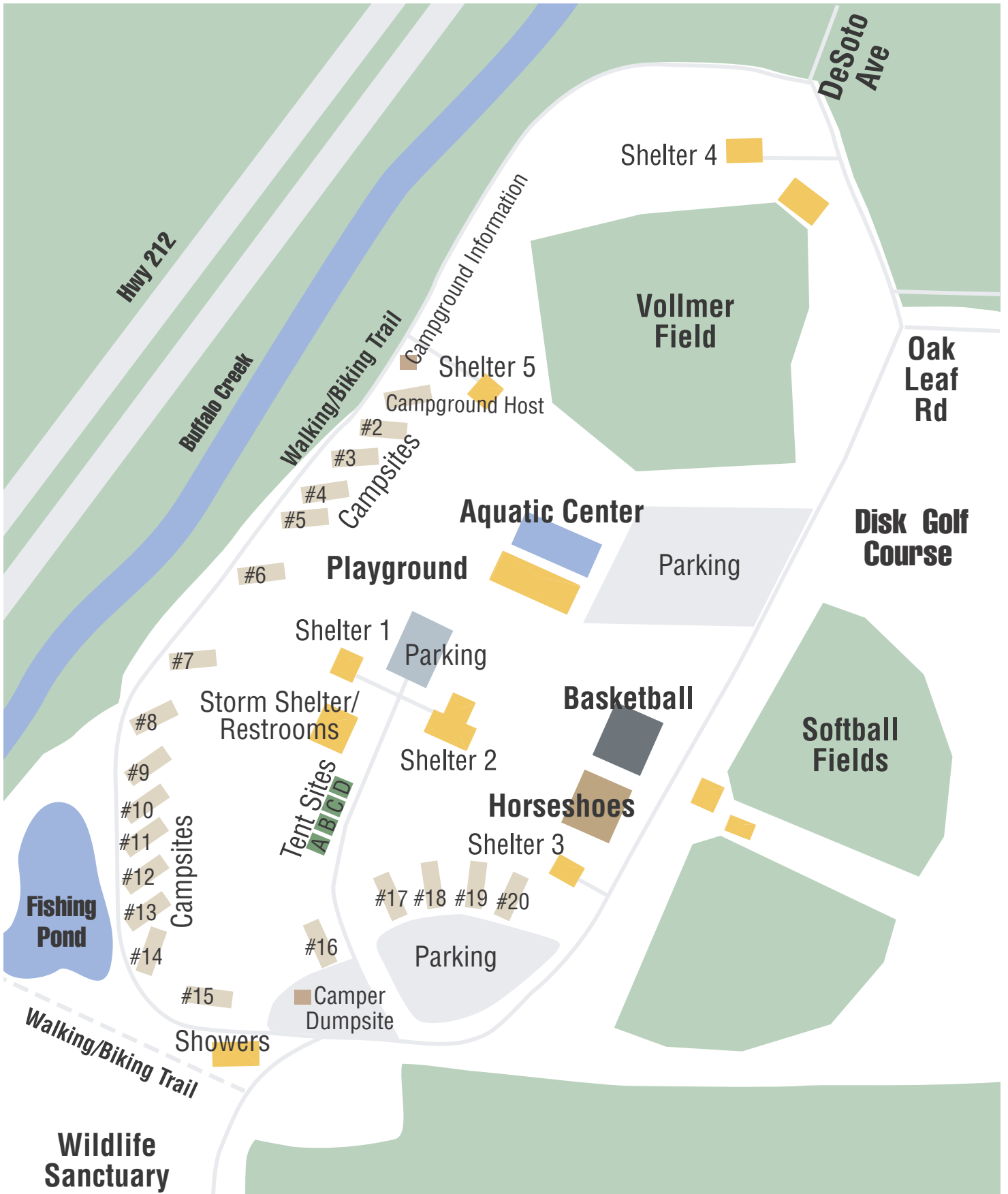
Another key recreational amenity in Glencoe is Oscar Olson Sunrise Park, located in the northeast corner of

Once you're done taking a dip at the pool, feel free to feed some of the wildlife at the local animal sanctuary on the far south end of Oak Leaf. Elk, llamas, and peacocks are just a few of the attractions that are sure to leave your kids in awe. Nesting bald eagles are also a popular seasonal attraction at the sanctuary.

For hikers and bikers, a trail goes around the entire sanctuary and park.

If you're looking for a new sport or hobby to pick up, look no further than

the nine-hole disc golf course. It offers a practice pin and plenty of easy and challenging holes for beginners or seasoned players — including hole six, which sits on an island in the fishing pond.

The course also is home to the longest hole in McLeod County — a near 600-foot shot from tee to pin — which takes players along the bank of meandering Buffalo Creek.

Tent and RV camping is available for \$20 and \$27.50 per night, respectively. A 20% discount is offered for stays of seven or more nights. There are 20 camper sites, 4 tent sites, and reservations can be made online at www.glencoe-mn.org.

in the wound center include bio-engineered skin grafting, compression therapy, debridement, edema management, negative pressure wound therapy, non-invasive vascular assessment, prescription growth factors, and specialty wound dressings. Patients can also seek treatment in the two hyperbaric oxygen chambers at GRH. The chambers expose a wound to 100 percent oxygen. The wound center has received the Center of Distinction Award by Healogics, the nation's largest provider of advanced wound care services.

Care at Every Stage

Transitional care is available at GRH in the hospital and at GlenFields. Transitional care offers a step between acute care and home for patients recovering from illness, injury, or surgery. The program can provide, among other services, intensive physical reha-

bilitation, advanced care for complex wounds, and nutritional support.

Emergency Services

GRH has been designated a Level IV Trauma Hospital by the Minnesota State Trauma Advisory Committee and an Acute Stroke-Ready hospital by the Minnesota Department of Health. Allina Health Emergency Medical Services (AHEMS) manages the GRH ambulance service, based in Glencoe.

Partnering with the Community

The Glencoe Regional Health Foundation encourages young people who are entering health sciences programs by providing education scholarships. In 2022, 70 students from the area were awarded Sanken-Hatz scholarships. The Foundation also furnishes grants to fund a variety of healthcare-related projects in the surrounding communities such as the new community walking path, Prairie Trail. 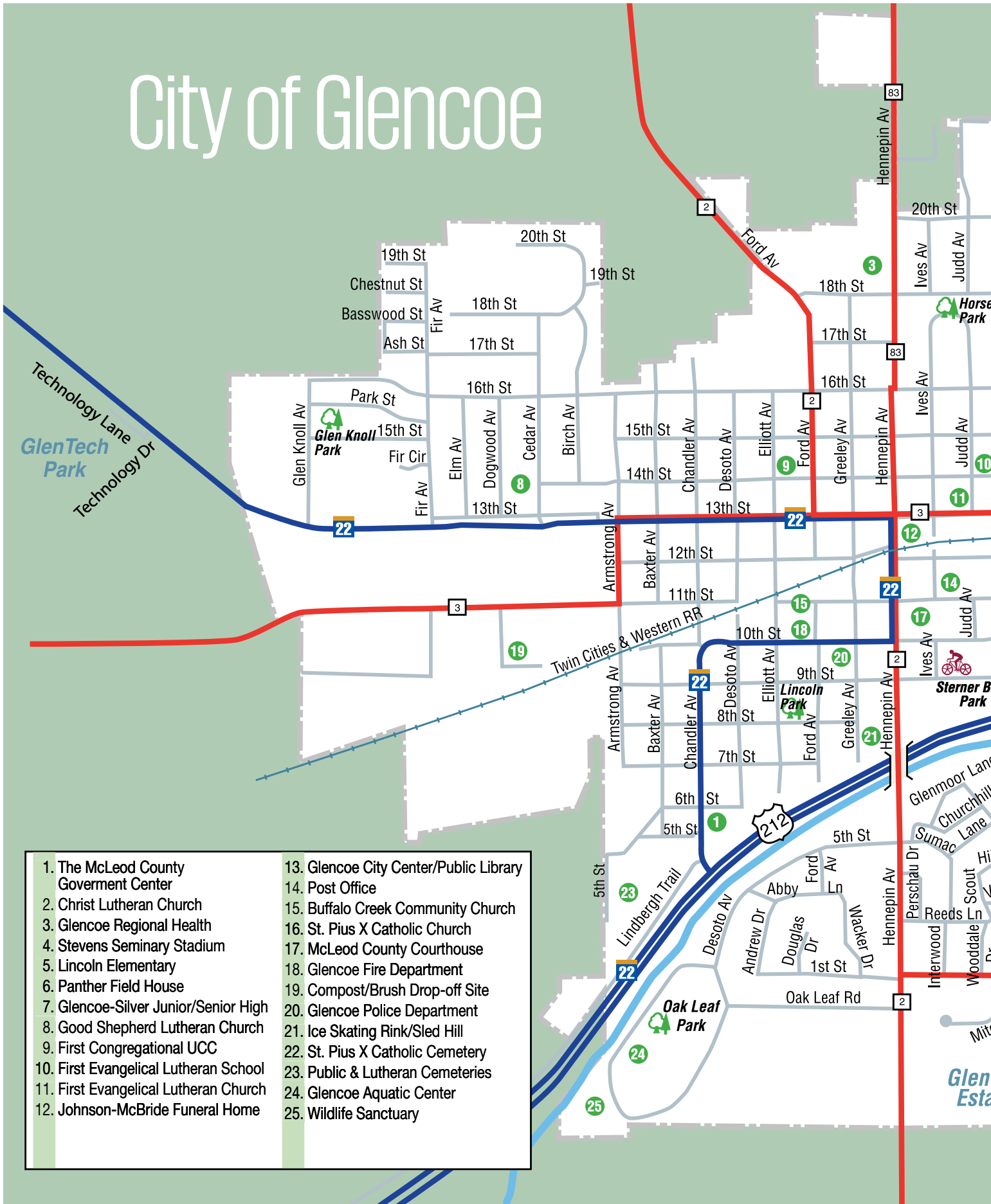

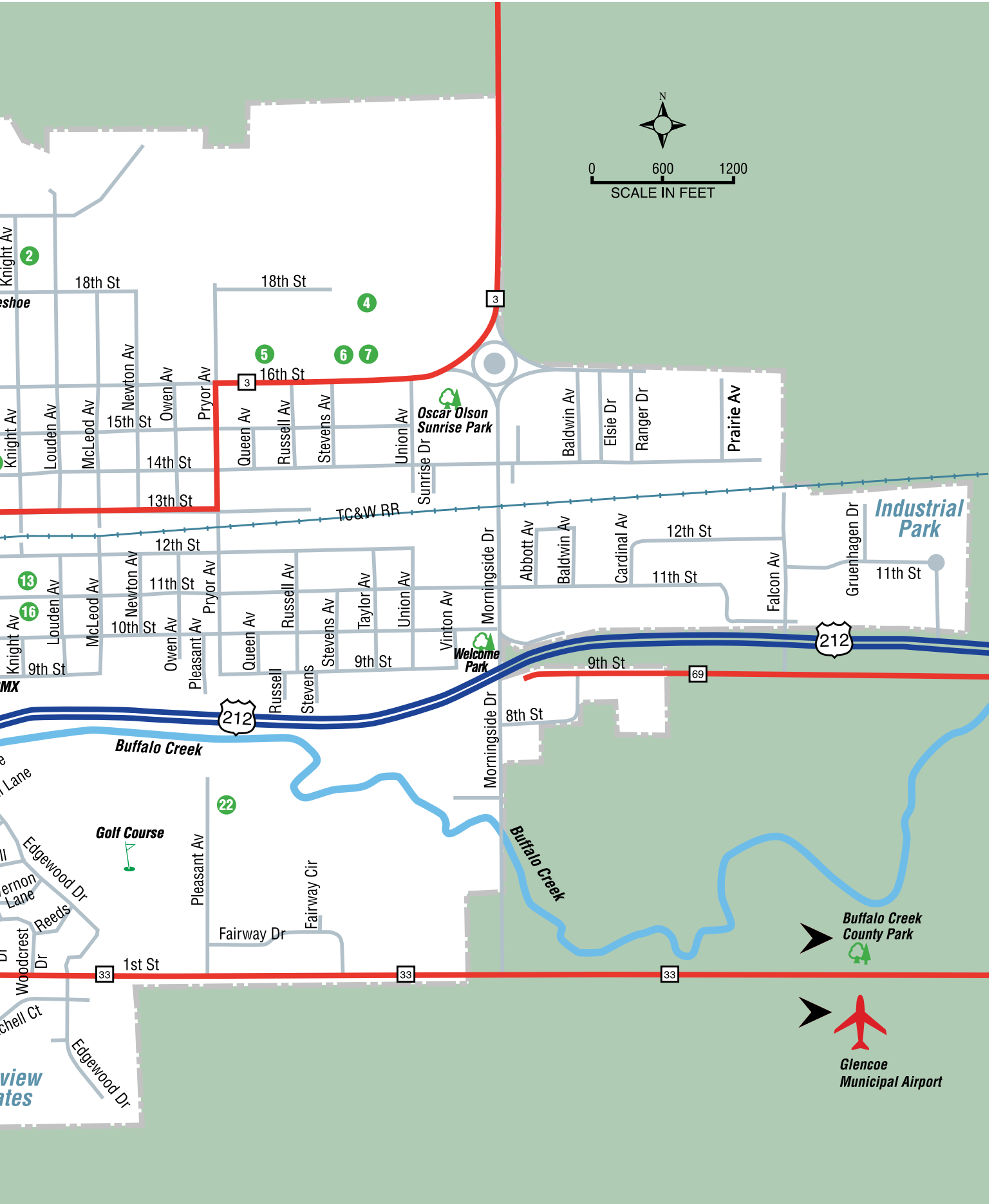

The Buffalo Creek BMX track is a unique feature of Glencoe that offers thrilling races and a place for children to hone their skills.

BMX track

The Buffalo Creek BMX track, located in Sterner Park at 1017 Ninth St. E. in Glencoe, is host to official weekly BMX races, and is open almost daily to the casual BMX enthusiast.

After a major renovation in 2020 that included paving corners and changing jumps, the approximately 900-foot track is

in its 15th season. The track welcomes youth bikers every Tuesday night for a series of races on its track full of bumps, banks and twisty turns. The Buffalo Creek BMX Club has about 35 riders from ages 3 to 40ish.

It also has hosted regional and state competitions. In June,

it hosted a regional meet welcoming over 400 BMX racers from across the state.

The track is a challenging draw to BMX bikers of all ages to test their skills and has become an increasingly popular draw each summer. The improvements have made the track one of the best BMX tracks of

the 10 in Minnesota.

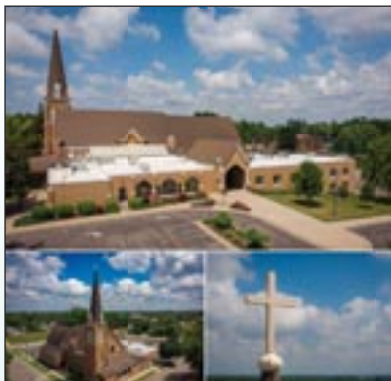

Glencoe History



Taken from the Glencoe Enterprise, July 21, 1955

In 1851, a party of hunters went from St. Paul, St. Anthony and Fort Snelling westward through where now are Carver, McLeod, Renville, Yellow Medicine and Lac qui Parle counties. Among the members of this party was Martin McLeod, a trader under Sibley at Lac qui Parle.

The comparatively limited area in the Minnesota country open to white settlement, and the fact that there was at that time so much desirable land in the United States pleading to be converted into homesteads, kept out immigrants from Minnesota until the concluding year of 1849.

Up to that date there were not one hundred white people in what is now Minnesota that were not Indian traders and their employees, officers and soldiers of the garrison at Fort Snelling; timber cutters and dam builders at St. Anthony; lumbermen at St. Croix Falls and Stillwater; members of a few families at St. Paul; half a dozen farmers in Washington county; and the missionaries and those in their service.

In August 1851, only a few days after the Treaty of Mendota had been signed, Thos. A. Holmes came up the Minnesota River in a canoe with William L. Quinn as his guide and selected the site of the towns of Shakopee and Chaska.

Carver was laid out in 1854, Carver and Chaska were steamboat points on

the Minnesota River not far away from McLeod County, noted as a beautiful country. It's varied expanse of prairie and timber, beautiful lakes and streams among fine and fertile dry lands made it an ideal location for the farmer and stock raiser.



Martin McLeod

It was on May 21, 1885, Col. John H. Stevens, Hon. Martin McLeod, A. J. Bell, D. W. Fields, James H. Mayall, J. V. McKeen, W. S. Chapman, John Johnson and Hon. Robert Vinton, a party of explorers and investors, constituted the advance guard of the set-

tlers which made the permanent white settlement of McLeod County.

At the border of the Big Woods and on the banks of Buffalo Creek, they located and laid out a town which they called Glencoe, a name which was historic, from the noted valley in Scotland. Glencoe is also Gaelic for a little valley: Glen, a valley; coe (a contraction of coeh) for small or little.

Originally timber covered about half of McLeod County on the northeast and this section was formerly a portion of the famous timbered tract known as the Big Woods. The wooded area included only that part of Glencoe on the southeast side of Buffalo Creek, west of the timber, the country, excepting the lakes, was found to be grassland or prairie.

The party of hunters, including Martin McLeod on reaching the site of Glencoe, determined to lay out a townsite. During the summer, fall and winter, Chas Hopkins, William Churchill, Peter Durfee, Henry Little, A. H. Rouse, Duncan McDougal, Dennis Corniea, Anthony Corniea, Prentiss Chubb, I. W. Cummings, J. V. McKeen, Mr. Bates, John Smith and others, founded homes. A townsite company was formed of which Andrew Jackson Bell was made chariman.

A party composed of Asa, John and A. Hudson Hutchinson, R. H. Pendergast, Lewis Harrington, B. E. Messer, John H. Chubb, Henry Chambers and others started out from Minneapolis in

November of 1855 and traveled westward until they struck a point of the south fork of Crow River, and there they laid out Hutchinson, named after the Hutchinson brothers.

The Sioux Indians during those first years, especially during the fall and winter hunting seasons, were always camped in the neighborhood, usually at some point on Crow River near Koniska or on Buffalo Creek above the village. They visited the settlers and exchanged venison for flour or meal and sometimes for tobacco. They were regarded as kindly but true to tradition; they possessed retentive memories and were sure to resent a prior injury, however long deferred.

In the summer of 1857, word came from beyond St. Peter that a family had been massacred by the Sioux in revenge for an injury inflicted by some member of the unfortunate family and that 700 mounted Indians were on the warpath and were headed in the direction of Glencoe.

The word was hastily communicated to the surrounding settlers on a Saturday afternoon with the request that they assemble at Glencoe with their families and bring all guns and ammunition at hand with them, prepared to make a stand in defense of persons and property should the Indians appear. The day following the report, most of the settlers around about had assembled at Glencoe, men, women and the children.

A. B. White, a blacksmith and a wagonmaker by trade, had been dispatched to St. Peter to procure such information as might be obtainable as to the whereabouts of the Indians and the direction from which the attack on the town might be expected.

Henry Jacobs, a German, then engaged in the merchantile business at Glencoe, was placed on guard on the traveled highway leading from St. Peter to Glencoe and at about 11 o'clock that night he heard the sounds of horse's hoofs approaching and assumed it was the advance guard of the 700 blood thirsty redskins armed with guns, tomahawks and scalping knives. He demanded who comes there, and the response came quickly, A. B. White of Glencoe.

The Indians never came and the fol-

lowing day the settlers returned to their homes and all fears of any attack by the Indians soon passed away.

Col. John Harrington Stevens, one of the most valuable citizens of Minnesota in early days, was a member of the party forming a permanent settlement. Writing of its operations in the Glencoe Register of May 15, 1858, Col. Stevens says that when this party came to the present limits of McLeod County, civilization had not reached this part of Minnesota, and there were no traces of the white race within a radius of 30 miles in either direction from Glencoe.

Col. Stevens writes that the party first thoroughly explored and examined the country, decided upon a location, and returned to Minneapolis. Within a few days thereafter, they had arranged to establish a sort of colony on Buffalo Creek.

A detail was selected from the original party to go and do the rough work. According to Col. Steven's account, the men selected to begin active working the new colony were Andrew J. Bell, William S. Chapman, J. V. McKeen, D. W. Fields and one or two others. It cannot be stated with certainty who these others were.

In the advertisement of Glencoe printed in the Register in August 1857, it is stated that the town was laid out in June, 1855 by Martin McLeod, John H. Stevens, Samuel Mayell, Franklin Steel, A. J. Bell and Issac B. Edwards. The Stevens account does not mention Steele, Edwards or Samuel Mayall, but names J. H. Mayall (brother of Samuel), D. W. Fields, J. V. McKeen, William S. Chapman, John Johnson and Hon. Robert Vinton, who are not mentioned in the Register article.

The pioneer party reached the site of Glencoe June 11 or about 20 days after the original explorers and immediately began the operations. After surveying the town site, Bell and Chapman began the erection of two small cabins and McKeen made his claim, which he afterwards owned.

There were some discomforts, the main probably the attacks of mosquitoes which came in great swarms, assailed them savagely and incessantly. The poor horses also suffered severely from the winged pests.

The town was named before it was

fairly founded. Martin McLeod suggested the name and everybody like it.

Slow progress was made during the first year of the existence of Glencoe because of the lack of lumber and other building materials

Andrew Bell and William S. Chapman to put up a sawmill at Glencoe to overcome the lumber shortage. Under the circumstances, this was not only an important but a serious difficult undertaking. All the machinery for the mill had to be hauled from Minneapolis or Carver. The roads to either place were new and in bad condition. The mill was not put into operation until August 1856, more than a year after the founding of the town. The first mill was built west of the Big Woods.

Farming was begun in the early fall of 1855. Little land was fitted for a crop that year and about 20 acres of potatoes were raised in the whole country of the Big Woods. Considerable plowing was done that fall, preparatory to cultivation the next year.

All the provisions that were used by the settlers in 1855, and the greater part had to be brought into the county through the woods from the Minnesota River, commonly from Carver. This transportation was difficult and expensive, involving the breaking down of teams and wagons, the traveling on bad roads, three and four days on one trip.

The first merchant in Glencoe was Francis W. Hanscomb, but he did not continue in business very long and then began farming. He was succeeded by Clayborne Chandler in June 1856.

The first blacksmith was Lawrence Gillick, an Irishman, who came in 1856. He was, like many of his countrymen, an ardent Democrat in politics. In 1860, he was census enumerator for McLeod County and did his work very well in spite of the trouble he had with the spelling of Norwegian, Bohemian, French and German proper names. In late life, he was for some years the town marshall.

The first minister in Glencoe, who was also the first minister of McLeod County, was Rev. Henry Elliott of the

Methodist Episcopal church. He was pastor of the M. E. church of Glencoe from April 1856 to June 1857 and was succeeded by Rev. John Pugh, and he by Rev. McWright, the second resident minister in Glencoe and the county.

On June 11, 1856, the citizens celebrated the first anniversary of the founding of Glencoe. On Aug. 15, 1856, the general store building of Henry Jacobs had been fully completed. J. Folsoms "Pioneer House," the principal village hotel and the barn in connection had both been remodeled and improved.

Ford & Elliott had built a carpenter's shop for themselves. Dean and Seaver's store building was finished in the early spring and painted white in August. Snyder & Close were running their steam mill. Bates & McKee's large hotel was nearing completion. C. G. Mickel had erected a shoe store. The new Register building was completed and the editor's dwelling finished about Sept. 1. The Register claimed that the population of the town was nearly 500.

Agitation had already begun to secure the extension of the Milwaukee & Prescott railroad west from Hastings or Nininger to Glencoe via Carver and Henderson.

The Fourth of July was enthusiastically celebrated in the town hall and 250 persons participated. Henry Little

presided, Rev. H. Elliott was chaplain, Wilber Elliott read the Declaration and L. L. Baxter of Glencoe and A. W. Freeman were the orators of the day. The Hutchinson Brothers (John, Judson and Asa), sang several songs, and at 3 o'clock there was a grand banquet.

The first numbers of the Register (in August 1857) contained an advertisement, (which ran several weeks) of the advantages, happy conditions and brilliant prospects of Glencoe. The advertisement read:

"Glencoe is the county seat of McLeod County, Minnesota. It is 45 miles from St. Paul and 60 miles directly west from Hastings and Nininger on the Mississippi. It is the center of the very best agricultural district in Minnesota.

The country between Glencoe and Carver (30 miles east), is covered with a heavy body of timber of the best quality for building and fencing purposes while on the west stretches far away to the Missouri River one of the most beautiful prairies in the world, dotted with small groves making most delightful places for the country residence and the farm house."

The first building burned in Glencoe was a house owned by C. E. Pettit, of Minneapolis, but which was occupied by C. L. Snyder and family at the time it was burned, which was in 1858. Mr. Snyder had \$2,000 in paper money which burned up.

The second building burned was a barn belonging to S. H. Harris and it, with a quantity of hay, corn, and farming implements, was consumed May, 22, 1859. The total loss by the fire was \$500, but it was regarded as a calamity.

In July, 1859, Buffalo Creek was under flood conditions. "It is higher than it has ever been before within the memory of white men," said the Register, advising that "steamboats of a good size could come up to Glencoe, and even go many miles farther up stream."

The first white child born in McLeod County was Winona Hoover, daughter of Mr. and Mrs. John Hoover, born Jan. 1, 1856, followed by Elizabeth Chapman, youngest daughter of Mr. and Mrs. William S. Chapman of Glencoe.

It was on June 24, 1857, Mrs. Eliza M. Cummins, wife of J. W. Cummins, died of typhoid fever, at the age of 27 years and 2 months. She was the first white woman interred in the then barren Glencoe cemetery.

The average monthly wage of a farmhand, with the board, was \$15; for a day laborer, with board, \$1.25; and without board, \$1.75; for a carpenter, without board, \$2; for a female domestic per week, \$2; and the price of board to laboring men per week was \$3.



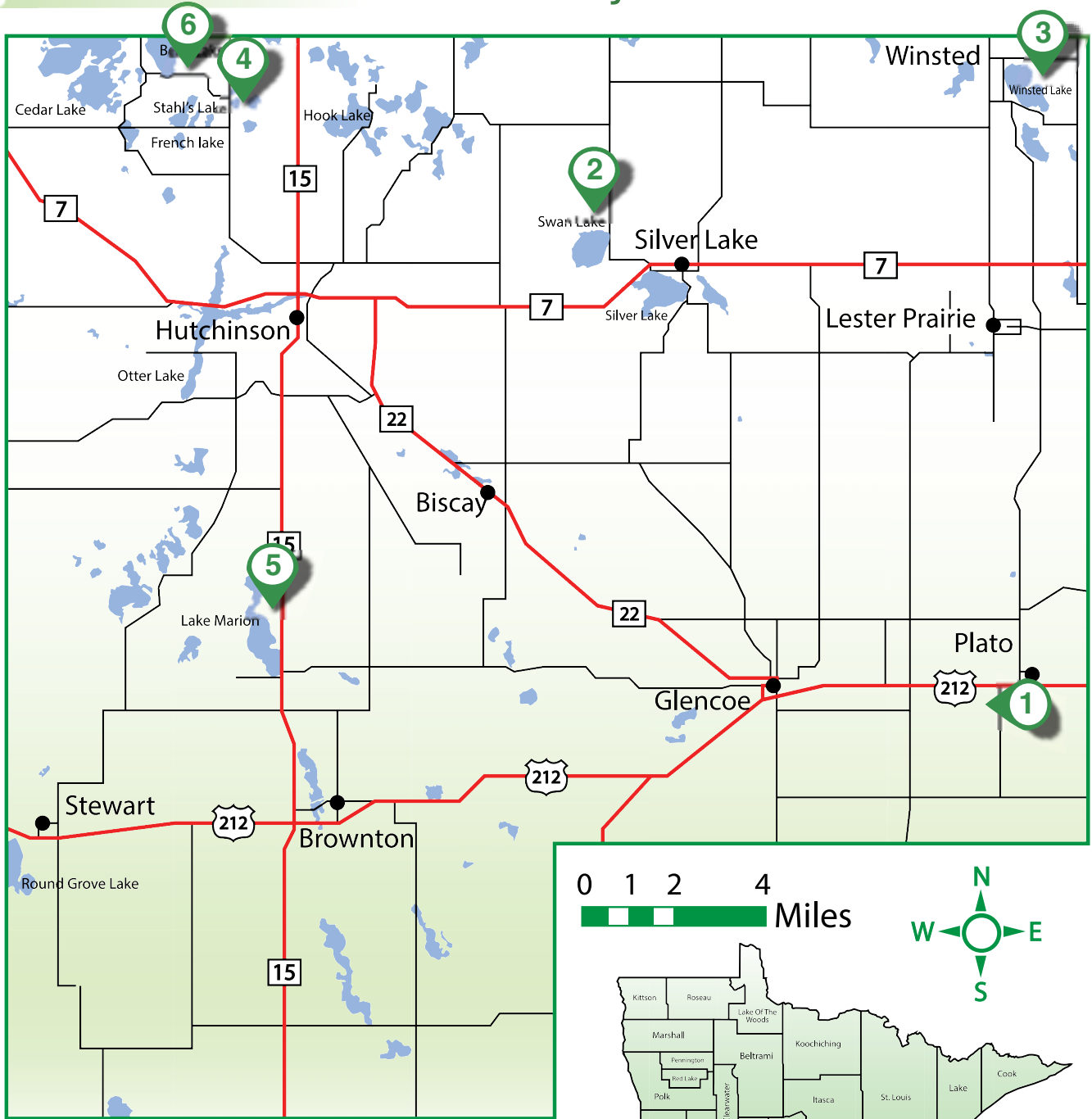
Dairy Day

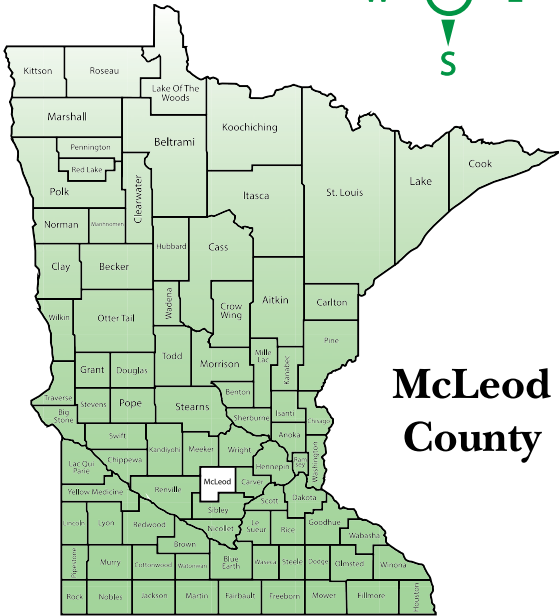
Other activities

County parks offer recreation options



Buffalo Creek Park

Located at 4956 100th St, Glencoe MN, three miles east of Glencoe on County Road 1. The park offers picnic shelters and walking trails.

The McLeod County park system offers services for everyone from an occasional picnic to a full-blown camping and fishing trip.

There are six parks in the system. Two of those — Lake Marion Park and Piepenburg Park — offer camping, public boat landings, volleyball courts, softball fields, picnic shelters, showers and other amenities.

Lake Marion Park is located on the northeast corner of Lake Marion, north and west of Brownton. It is served by U.S. Highway 15 and located about 12 miles west of Glencoe. Those coming from Glencoe can reach the lake by driving west on County Road 3 (110th Street).

The 86-acre park opened in spring 1981. The land, which was formerly home to one of the larger mink ranches in the United States, was bought in 1975.

The facilities available include two picnic shelters and grills, a one-mile hiking trail, a beach (no lifeguard on duty), a fishing pier, boat landing, main shower building, camper dump station, playground equipment, volleyball pit and a softball field. Also, in season, there are groomed cross-country ski trails.

Lake Marion Park offers campers 36 RV sites and 14 tent sites.

There are many campsites available. Fees for campers who require electrical service are \$30 a day.

Fees for campers who do not require electrical service are \$23 a day (per tent).

Reservations can be made online only on the county website, www.mcleod.mn.us under the Parks tab starting on the last Monday in February at 8 a.m.

There is a \$35 fee to reserve a park shelter at any of the county parks. Contact the McLeod County Parks Office, 320-484-4334, to make reservations.

On the south edge of Lake Marion is the Brownton Rod & Gun Club, which offers a boat landing, a picnic and beach area. Each Friday night at the clubroom, there is a steak and pork chop fry.

Piepenburg Park is located on the southeast corner of Belle Lake. From Hutchinson, go north on Highway 15 to County Road 60, turn west and continue for 5 miles.

The park features two picnic shelters with grills, a red rock trail, a beach (no lifeguard on duty), a boat landing, a fishing pier, a main shower building, a camper dumping station, natural prairie, playground equipment and horseshoe pits, volleyball court and softball field.

The fees for camping and the park shelter are the same as for Lake Marion Park. Again, reservations can be made online on the county website, www.mcleod.mn.us.



Reservations for the park shelters at Piepenburg may be made by contacting the county parks office.

Buffalo Creek Park, 3 miles southeast of Glencoe (near the airport), is a little more than 45 acres and features a picnic shelter with tables and grills, playground equipment, open space activities, nature trail, duck pond, and a large stand of spruce trees.

Swan Lake Park is located 3 miles northwest of Silver Lake on County Road 16 and is 82 acres in size. It features a picnic shelter, fishing pier, grills, open space activities, nature trail, duck pond, and a large stand of spruce trees.

William May Park is located 3 miles east of Winsted off of County Road 85. Seventy-one acres in size, it features a picnic shelter, tables, grills, nature trail and a large stand of maple trees.

Stahl's Lake Park is located 6½ miles northwest of Hutchinson and is 127 acres in size. It features a picnic shelter, tables, grills, a boat tile connecting French Lake to Stahl's Lake, a nature trail, a duck pond, a tree nursery and groomed cross country ski trails.

The hours at all the parks are from 8 a.m. to sunset.

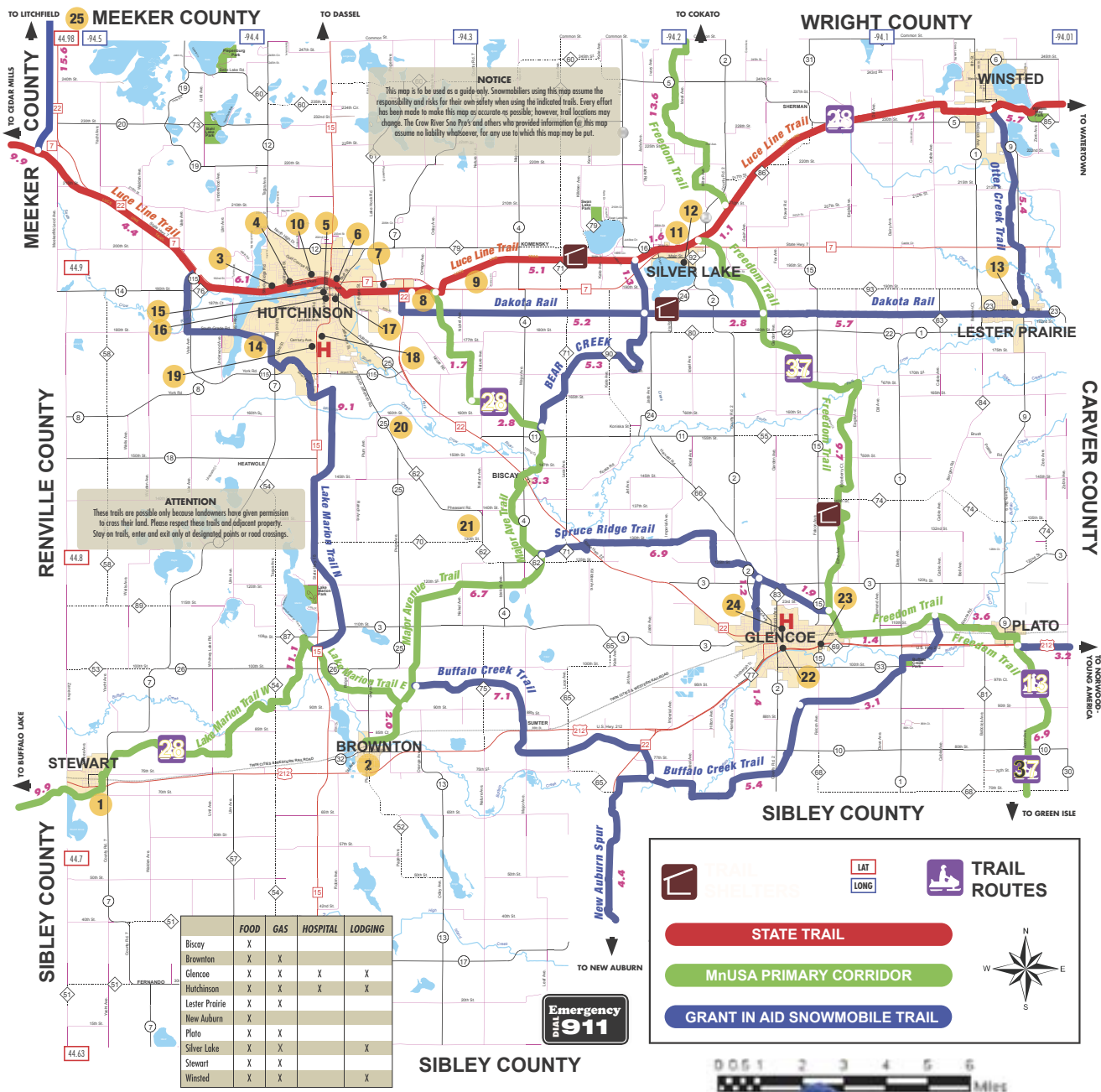
